1. **Call to Order:** Mayor Cameron Hankins called the meeting to order at 6:46pm.
2. **Pledge of Allegiance:**
3. **Approval of Minutes:** Regular meeting held May 12, 2022. Motion by Tammy Holicky, seconded by Bob Busta to approve the minutes as written. Unanimous vote. Motion carried.

5. **Staff Announcements:** Highway 3 construction is anticipated to start July 11th.

H) Railroad Ave N: Quote was over \$100,000 without blacktop. The Mayor will get 4 to 6 bids on the project.

12. Council Discussion: There was a complaint on mowing the library property during an event at St. Canice. Jason Moran wants the council to be aware of the Wallace court date for nuisance property violation. The City is going to buy a new lawn mower and there was talk on wage increase for the City Clerk.
