REGULAR MEETING
October 13, 2020**

There was a regular meeting of the Kilkenny City Council held in Council Chambers on October 13, 2020.

1. **Call to Order.** Mayor Cameron Hankins called the meeting to order at 7:01 pm.

 - A) **PeopleService Contract:** Our current contract ends this year. The proposed new contract was discussed and there were questions. The clerk will call PeopleService to see if Herb Krueger can attend the November meeting to answer questions.

 - A) **55 Loop Reimbursement:** There is a question as to whether the City has been payed this year for the snow plowing for the County 55 loop. Jason Moran will follow up tomorrow with the County Administrator. Jason Villwock will itemize his bill this year to see if it is worth it for the City to be responsible for the plowing. The question was asked if Groundmasters sweep the 55 loop or does the County do it?
